Ushahidi catalyzes initiatives in Kenya like the iHub to support entrepreneurs and grow the innovation ecosystem In 2011, both Ushahidi and Crowdmap were deployed across the globe for large and small humanitarian and crisis responses. The largest three deployments for humanitarian responses were indicative of the power of crowdsourcing on a global scale: New Zealand, Japan and Libya. The Christchurch New Zealand Earthquake was a large collective effort and unique due to incorporating official emergency responders within the efforts. The Japan Earthquake and Tsunami (Sinsai.info) has over 10,000 reports and included hundreds of volunteers from around the world and within Japan.
